2019



2019 has been a transformational year for Pemberton and I am very proud of everything we have achieved. In the first half of 2019, we held closes on our flagship European Mid-Market Debt Fund II and our debut Strategic Credit Opportunities Fund I, bringing the total amount of capital raised since June 2018 to €4.2bn.

During 2019 we completed 30 investments across Europe and deployed approximately €3bn of capital. Of the 30 investments, we added 22 new portfolio companies and worked with our existing borrowers to finance 4 add-ons and 4 refinancings. The pace of our deployment has been underpinned by the strengthening of our local origination network having opened offices in Amsterdam and Copenhagen this year and hiring 9 additional investment professionals.

We have also started fundraising for our Mid-Market Debt Fund III, Strategic Credit Fund II and Senior Loan Fund I. We continue to raise for our Payables and Receivables Opportunities Fund, which has commenced deploying in 2019.

Responsible investing remains core to our values and we have strengthened our ESG policy both internally and with respect to our portfolio companies. We have also rolled out a firm-wide CSR programme and I look forward to reporting back on these in a year's time.

From all at Pemberton, I'd like to thank our investors, borrowers, private equity sponsors, advisors and banking partners for your continued support and we look forward to working closely with you in 2020.

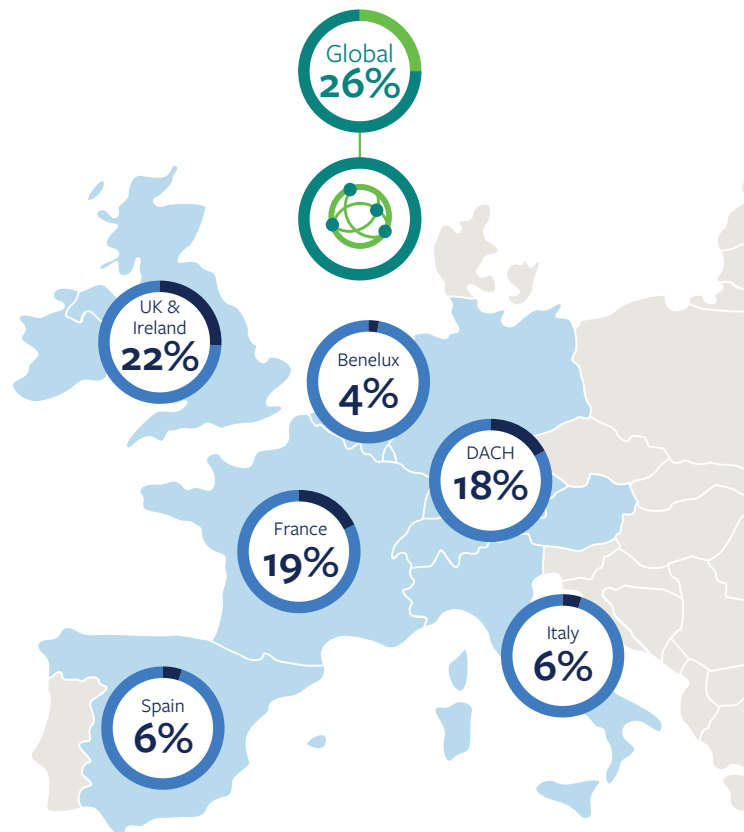

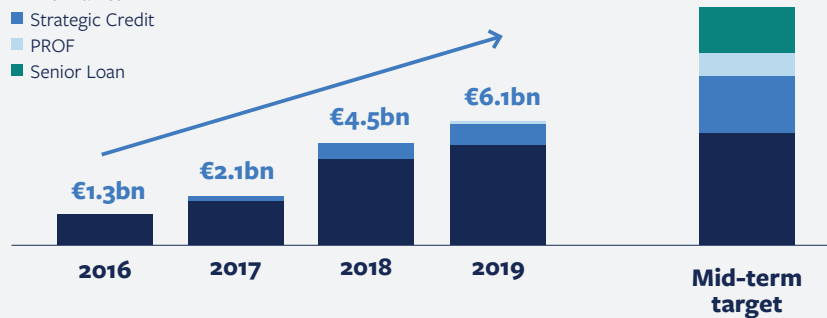
